Conference Hotel

The Hilton Eugene & Conference Center is the host hotel for NUSA's Annual Conference. The conference hotel rate is \$99 a night (not including taxes). Reservations for hotel rooms will open at a later date.

Who's Who Award Recognizes Individuals In America's Neighborhoods

Neighborhoods, USA established the Who's Who in America's Neighborhoods award as a way to recognize individuals who are neighborhood leaders or who have an obvious and professional dedication to neighborhood issues at the grassroots level and have made their communities better places to live, work and play.

Ideal candidates are individuals whose work exemplifies NUSA's mission to build and strengthen neighborhood associations, encourage neighborhood involvement in the decision-making process in their local government and work to promote productive communication and collaborations between neighborhood associations, local government and the public/private sector.

No more than four individuals may be selected for the Who's Who in America's Neighborhoods Award each year. Only current NUSA members may nominate an individual for consideration and only one nomination per person is allowed every year. Current NUSA board members are ineligible for nomination.

Nominations must include:

- A description of the nominee's neighborhood involvement.
- An explanation of how the nominee has proven to be a leader in their community.
- An explanation of why the nominee deserves the Who's Who award recognition.

Best Neighborhood Program Award

Established in 2007, the Best Neighborhood Program award recognizes the outstanding work of government entities and businesses for their work to improve the quality of life in their communities. Best Neighborhood Program awards are given in two categories: Social Revitalization and Physical Revitalization.

To be eligible for the 2014 award, applicants must have completed a noteworthy neighborhood improvement project in 2013. Award application guidelines can be obtained by visiting <http://www.nusa.org/nusa-awards/award-application>.

All submissions must include the \$100 entry fee and be postmarked by February 1, 2014. 2014 Neighborhood of the Year Awards

2014 marks the 30th year that NUSA will recognize the outstanding work of neighborhood organizations, from all across the United States, for their efforts to improve the quality of life in their communities.

Neighborhood associations may compete in three Neighborhood of the Year award categories:

- Physical Revitalization/Beautification - Projects that focus on physical aspects of improving a neighborhood, such as parks, lighting, litter control, traffic management, housing improvements, green spaces or business district enhancements.
- Social Revitalization/Neighborliness - Projects that focus on the social or cultural aspects of a neighborhood and make neighbors feel connected to each other.
- Multi Neighborhood Partnerships - Projects, undertaken by a least two neighborhood and/or community organizations in partnership, that focus on social or physical revitalization efforts.

A panel of national neighborhood leaders will review applications and select a minimum of four finalists in each category. Finalists then will present their projects, with in-person presentations, to a judging panel during the 2014 NUSA Conference. A first

place winner will be selected in each category, and those winners will then be evaluated to determine the grand prize Neighborhood of the Year winner. All winners will be announced during the Neighborhood of the Year luncheon on Friday, May 23.

Newsletter Award Recognizes Excellence in Communication



Established in 2010, the Neighborhood Newsletter Award highlights the importance of a vital communication tool for neighborhood organizations, community groups and local governments. The competition features three award levels: Gold, Silver and Bronze and two categories: Electronic Format and Print Format. Each entry will be evaluated by a panel of judges for content, layout and overall appearance.

To enter the competition, two consecutive issues of a newsletter published in 2013 must be submitted with a completed application and entry fee - \$50 for electronic format submissions and \$65 for printed format submissions. Entries must be postmarked by February 1, 2014 in order to be eligible for consideration.

Winners will be announced during the 2014 NUSA Conference being held in Eugene, Oregon from May 21-24, 2014. Entrants need not be present to win.
